- -Reforestation as restoration
- -land use changes in Sussex County increased development decreased agriculture and forest and wetland
- -after 2010 land preservation by county decreased most likely due to decreased in funds for conservation
- -forest and vegetative buffer loss
- -priorities for CIB
 - -protect remaining natural areas
 - -restore degraded
 - -buffers
 - -fragment connection
 - -species reintroduction
 - -improve water quality
- -Habitat restorations
 - -living shorelines and wetland restoration
 - -stormwater retrofits

- -fish passage projects at dams (eelways)
- -oyster reefs
- -agricultural parcels prioritized for watershed reforestation
- -public and private land project development
- -Angola Neck Preserve (Perry Track) (Angola)
 - -volunteer tree planting
- -Bullseye Ferry Landing Preserve (Millsboro)
 - -owned by Nature Conservancy DE
- -Sassafras Landing (Little Assawoman Wildlife Area)
 - -deer fence-deer cause major obstacles on tree reforestation projects
- -Muddy Neck (Selbyville)
- -Burbage Road Wetland and Reforestation
 - -Sussex County owns
 - -partnered with Sussex County Conservation District for this project
 - -wetland plants will be planted this spring hopefully by volunteer
 - -deer tubes around trees
 - -salted vine winery to partner with CIB for tree planting + wine tasting event may try again in the spring
 - -Sussex County may accrue stormwater credits

 - -DE Wild Lands partnership
 - -wetland restoration

 - -irrigation system upgrade
