6:35-7:05 CIB Storytelling

Zach Garmoe – Environmental Science Coordinator, Delaware Center for the Inland Bays

Project Coordinator of the survey; lots of volunteers. April to October and 16 sites. Bimonthly 3 per site. Andrew McGowan does the research. 12 years ago looking at near shore areas rather than DNREC trawling. Near-shore fish – forage fish and juvenile managed species. These are fish for larger fish. Also good for osprey. Important to follow protocols. 32,967 counted in 2021. Natural variation year-to-year. Some species slow growers. 4270 blue crabs – much younger crabs surveyed. 47 species caught in 2021.

Included some DNREC data. Catch per tow increased in the past five years of blue crabs. Seining in the bays is usually young and takes time to show in larger fish. Atlantic Marine Fishery Council needs 10 years of data and CIB now has 10 years of data.
