Operating reserve has \$162,658 goal to be raised over 2 – 4 years per Board policy, existing programs must raise \$50,382 this fiscal year, and JFMP needs \$120,000 - \$150,000 to go to construction on Phase 1 (originally scheduled for Spring or Fall 2018).

Review of ongoing fundraising actions: annual appeal, James Farm Master Plan, outstanding asks/actions.

\$25,000 for Marketing is in the budget this year and a spend plan will be developed when the new Outreach & Education and Development Coordinators begin work.
